### Selection of 12 Users

EHRI has a fellowship programme. Every year twelve researchers will be invited to stay for a period of four weeks to two months at an EHRI partner institute (4 at MS, 2 each at IfZ, JMP, NIOD and YV). There will be three calls, for 2012, 2013 and 2014. The EHRI fellowships are intended to support and stimulate Holocaust research by facilitating international access to key archives and collections related to the Holocaust. The fellowships intend to support researchers and younger scholars, especially Ph.D. candidates with limited resources. Candidates from Central and Eastern Europe are especially encouraged to apply.

The call for applications for 2012 was issued in the summer of 2011 and circulated widely. Overall 75 applicants from 22 countries applied for an EHRI fellowship. An international panel of experts selected the researchers on the basis of their research programmes. Experts included PD Dr. Frank Bajohr (Universität Hamburg, Germany), Prof. Dr. Benjamin Frommer (Northwestern University, IL, USA), Dr. Christoph Mick (University of Warwick, UK), and Prof. Dr. Geraldien von Frijtag Drabbe Künzel (Universiteit Utrecht, the Netherlands).
