Introduction

During the German occupation of large parts of Europe (1939-1945) policing was also enacted by national police forces of the occupied countries. These national police forces were taken over or (as in parts of Eastern Europe) newly created. They often outnumbered the German police by far.

Without this 'auxiliary' police, the enforcement of Nazi rule would have been impossible, especially on the local level. National police forces remained responsible for the persecution of regular criminality, and for everyday public order. But they also had to enact specific Nazi policies, more specifically the cooperation in the persecution, deportation – and in parts of Eastern Europe, killing – of Jews. Although the German Police and SS apparatus remained the driving force of this policy, the practical implementation relied heavily on national police on the local level.

Despite the subject's importance, there has only been limited transnational historical research into these occupied police forces. Most of the literature deals with national cases, or specific cities/regions. There is no transnational comprehensive overview. This conference aims to

integrate the existing research on a European level, in particular from Central and Eastern Europe. It also envisages to open new transnational and comparative perspectives on collaboration in general.

The focal point of the conference lies with the Holocaust. This will also be used as a stepping stone for comparison between police structures (personnel, organization, command, identity) under Nazi and Axis rule, as well as the comparison between the actual operation of the occupied national police. In doing so, we will also try to compare and analyze the different structures on the background of societies under occupation.
