Abstract (for dissemination)	With a view toward deepening and enhancing emerging international collaboration and with a particular focus on stimulating the development of local networks, WP4 will foster research communities in four countries: Italy, Romania, Poland and Slovakia. This deliverable will outline first steps toward engaging with a network of archive and library leaders, as well as research experts in each country in order to channel a cross-disciplinary discourse on the opportunities and challenges of working with Holocaust documentation. These steps include compiling lists of institutions, as well as planning activities tailored to the local context, in order to foster a local network, gather knowledge on local requirements and keep experts engaged in EHRI. The deliverable further reports on the pilot workshop conducted in Italy and an evaluation of this activity.

1 Introduction

The development of international communities of experts has played a central role in EHRI since the start. EHRI made great advances in connecting international experts with regard to Holocaust documentation from a large range of areas: collection management, preservation, conservation, cataloguing, and access.

The focus of WP4 "Localisation and capacity building" lays on deepening and enhancing this emerging international collaboration. WP4 particularly focuses on stimulating the development of local networks in places where practitioners often work in isolation and have insufficient access to expertise and resources. Thus, priority is given to geographical areas and archives where there is less knowledge in the handling of Holocaust documentation, and places where specialists have fewer opportunities to meet their peers in Europe. This can, for example, be the case for archives in Southern and Eastern Europe, smaller archives, as well as for archives that are not devoted to the topic of the Holocaust, or where the staff only has limited knowledge about this specific field.

By fostering an exchange between emerging local networks and international experts, WP4 contributes to local capacity building and increases the understanding of the challenges that Holocaust experts face in different local settings.

Hence, WP4 employs a variety of tools, such as workshops, seminars, a mobile experts' lab, communication networks, online publications and more.

2 Integrating new research communities

Task 4.3 "Integrate regional communities and related initiatives and integrate new research communities" aims at fostering research communities in four countries: Italy, Romania, Poland and Slovakia. In each country, members of Task 4.3 are engaging with a network of archive and library leaders, as well as research experts in order to channel a cross-disciplinary discourse on the opportunities and challenges of working with Holocaust documentation. The work is being conducted in pairs of EHRI partners: a local partner and an external partner. In each country, a team of leaders of archives and libraries holding Holocaust documentation come together in work meetings.

2.1 Fostering regional research communities

In order to facilitate such exchange between experts from archives, libraries and universities, the institutional partners from the Fondazione Centro di Documentazione Ebraica Contemporanea (CDEC), the Elie Wiesel National Institute for the Study of the Holocaust in Romania (INSHR-EW), the Emanuel Ringelblum Jewish Historical Institute (ZIH), and the Holocaust Documentation Center in Bratislava (DSH) compiled lists of 54-63 institutions in their respective countries so as to have a better understanding of the local experts in the field. The lists of institutions can be found in Annex 1.

In order to nurture local research communities, it was agreed to organise initial workshops in each country, tailored to the local context, so as to foster a network of local experts, gather



knowledge about each country's requirements, and keep the experts engaged in EHRI activities. A workshop in Italy served as the case study and shall inform on how to conduct the upcoming introductory workshops for the Romanian, Slovakian and Polish research communities. This first workshop for Italian experts also serves as the foundation for the advancement of a regional research network in Italy.

2.1.1 Workshop "EHRI in Italy: Expanding the Research Community Network"

Within the work package "Localisation and Capacity Building" in EHRI-3, Yad Vashem, the Arolsen Archives and Fondazione Centro di Documentazione Ebraica Contemporanea (CDEC Foundation) organised the workshop "EHRI in Italy: Expanding the Research Community Network", which took place on Zoom on July 1st, 2021. The workshop was led by Lorenzo Camerini (Arolsen Archives) and Laura Brazzo (CDEC Foundation).

The workshop was aimed at a multidisciplinary audience of archivists, scholars, educators and representatives from Italian Jewish Communities and institutions. Its objective was to introduce the potentials of fostering a local research community in Italy, as well as to familiarise the local research community with the benefits of working in the framework of the European Holocaust Research Infrastructure.

The first part of the workshop was held in English. Karel Berkhoff (NIOD - Institute for War, Holocaust and Genocide Studies and EHRI-3) opened the workshop with an introduction to EHRI, which was followed by Alexander Avraham's (Yad Vashem) presentation of Yad Vashem's Archives and the variety of resources they make available to researchers worldwide.

The second part of the workshop was held in Italian. Lorenzo Camerini presented the history and activities of the Arolsen Archives, as well as their indexing crowdsourcing project #everynamecounts. Laura Brazzo then concluded the presentations by giving an overview of the Italian institutions represented on the EHRI portal, highlighting the benefits arising from such public visibility.

In the final part of the workshop, the approximately thirty attendees gathered ideas, recommendations and visions for the establishment of an Italian research community related to EHRI and showed a strong interest in contributing to and taking part in future EHRI activities.

2.1.1.1 Evaluation of the workshop "EHRI in Italy: Expanding the Research Community Network"

Consistent with the aims of WP4, the workshop in Italy was developed as a preliminary event, to introduce EHRI-3 to the participants, explain its aims and objectives and to familiarize the Italian research community with the benefits of working in the framework of the EHRI.

The invitation was addressed to professionals and experts from various areas and disciplines - scholars, archivists, record managers, digital humanities experts - who might be interested in becoming part of an interdisciplinary network of experts in the field of Holocaust studies in Italy, and which would interact in subsequent events.

The private organizations and researchers expressed a desire to become members of an active network during the workshop and in the final discussion session. According to them, the function of this network should be to guide, support and educate about Holocaust studies, as smaller institutions and organizations that work locally sometimes experience troubles to work and interact in larger frameworks.



The Italian experts also highlighted the need to involve institutions and subjects who are not included in Holocaust research, as often not considered alwavs relevant. Researchers underlined the importance of researching university archives in order to study the discrimination of Italian Jewish professors and students after the Fascists' Italian racial Laws of 1938 ("Leggi Razziali"), as well as hospital archives in order to study the stories of Italian who offered support to the persecuted Italian Jewish doctors population. A further important aspect the workshop participants pointed towards, is the dramatic situation of small municipality archives, which often have been abandoned and forgotten, without having undergone any research - but which may be of great relevance for Holocaust research in Italy.

Both the lively final discussion and the large number of participants point to an interest in such events and a desire to be involved in future activities concerning Holocaust research in Italy. Subsequent events, in accordance with the participants' suggestions obtained during the workshop and the survey, can contribute to the consolidation of EHRI's presence in Italy, to the expansion of the network and the integration of new research communities. As EHRI is perceived as a great support possibility for research, education and information, it is important to develop a series of regular events, in order to keep the participants of the first Italian workshop engaged in EHRI.

As also shown by the partial results of the survey "Mapping Grass-Roots Needs for Expanded EHRI Services and Networking" sent to the participants at the end of the event, EHRI is perceived as a great resource, especially for educational purposes and practical advice (see Annex 2). At the same time, the limited results obtained from the survey lead us to reflect on the use of new tools to obtain more complete and comprehensive feedback from the participants.

2.1.1.2 Evaluation of the Italian responses to the survey

EHRI continually expands the group of people, institutions and Holocaust-related collection holding bodies associated with the project. EHRI wishes to greater understand the challenges that Holocaust experts face in different local settings, in large and small organizations, and to provide services tailored to the needs, circumstances and priorities of the different localities. In this context, EHRI intends to establish a "Mobile Lab", comprised of experts from different countries and disciplines, which will offer a range of services to organizations, according to their choice and needs. WP4 further intends to identify relevant groups of experts in sub-specializations of Holocaust documentation, and create networks and platforms where such experts' groups can meet, exchange information and consult.

Thus, the partner institutions in Task 4.1 developed the survey titled "Mapping Grass-Roots Needs for Expanded EHRI Services and Networking" and distributed it to 1924 institutions in 53 countries. The survey aimed at raising the understanding about the different institutions' needs and incorporating them in the development and refinement of EHRI's services and networking activities.

This survey was also sent to the participants of the workshop "EHRI in Italy: Expanding the Research Community Network". Out of the 30 attendees, 14 opened the survey and for most questions, approximately 5 people responded. This points to the challenge of committing participants to answering this type of survey, which was shared with the participants prior, during and following the workshop. Potentially, more attention needs to be brought to the



question of language when it comes to the survey, as English might have represented a language barrier for Italian experts to participate in the survey.

Especially question 4 "For which of the following aspects would you/your institution be interested in receiving from EHRI?" showed that there is a strong interest for consultancy, lectures and practical advice in the following areas: handling testimonies and photographs; using thesaurus and key words; mapping; arranging materials for digitization; indexing; and understanding the EHRI portal tools.

As shown in question 5 "What is the nature of the service that you/your institution would like to receive?", the respondents are inclined to receive lectures, different forms of consultancy and workshops alike, while being less interested in instructional videos.

An interesting take-away that showed-up in question 6 "If you had an option between a physical/in person vs. an online/virtual setting, what would be your preference for the following services?" is that most respondents would prefer to receive the different services online. Of course, it should also be considered that this might be related to safety measures due to the covid-19 pandemic.

2.2 Guidelines for integrating regional research communities

At the current stage of the work conducted within task 4.3, some general considerations can be drawn up for the realization of the guidelines for integrating regional research communities. These guidelines will be improved and further developed following the upcoming workshops for the research communities in Slovakia, Romania and Poland.

First of all, it is crucial to actively involve local experts and experts on a regular basis, not only to better understand the local issues in Holocaust research better, but also to build a foundation of trust and collegiality for the development of a local research community.

A further possibility to strengthen the cooperation between local experts and EHRI, is to offer a range of services to local institutions that are involved in Holocaust research in a given country, depending on the local experts' needs. Such services can include the preservation, arrangement or digitization of documents. This could furthermore serve as a possibility to increase the visibility and outreach of EHRI. Yet, these services cannot be easily addressed with online support and the possibilities to travel across Europe to support regional research communities is largely hindered through the pandemic.

Therefore, it would be advisable to plan a larger number of shorter events and webinars with a low threshold, which could help in keeping a constant interest in the research communities, while not overextending the capacities of the work package members through possibly cancelled in-person events.

Thus, especially in the meantime, but also in the long run, it would be of importance to sustain a research community by creating a virtual room for interaction, which invites the participants to engage in meaningful discussions, as well as to share experiences and insights.

An important aspect to point out in the development of services, events and meetings for these research communities is language. Especially in more peripheral or smaller institutions, the



use of the national language for communication is recommended, even more so when it comes to technical and scientific terminologies. A hybrid solution to consider could be to use standardised English slides during online or on-site workshops and seminars, but to present in the local language.

The next event in planning within task 4.3, is a contribution to the in-person workshop "Holocaust in the Slovak-Hungarian Borderlands: Archives, Research and Digital Humanities" in May 2022, which has been initiated by WP9. There, task 4.3 will contribute with activities that can strengthen a local research community related to the Holocaust and sustainably connect them to EHRI. Due to the worsened pandemic situation in Slovakia, the workshop has been postponed from September 2021 to the following year. The workshop aims are to bring together communities of historians and archivists working at various institutions who are professionally involved in Holocaust studies, with an emphasis on the territory of today's southern Slovakia, which was part of Hungary during the Second World War. Another of the planned objectives of the workshop is to start a discussion on the challenges of Holocaust research in border areas (differences in terminology, accessibility of archival materials for researchers, etc.) and then to try to apply the results of the workshop to other such border areas within Central and Eastern Europe.



Q4 For which of the following aspects would you/ your institution be interested in receiving services from EHRI? feel free to check and rate multiple options:






